New laws in in states like North Carolina make it clear that your practice will soon need to submit data directly through a mandated Health Exchange (or registry). Your software must be government certified to meet mandated changes. We are already working with exchanges in multiple states to ensure these capabilities exist when you need them.

Our new building in Weeki Wachee, Florida is almost ready for occupancy. The builders finished sheetrocking last week. Once we move in, you can schedule an appointment & visit us to get free in-person training during regular business hours. We expect to move by September 2019.

The ECLIPSE patient portal was government certified in 2018 & is now available. There are no additional fees to use the portal — but it requires a Client/Server version of ECLIPSE to take advantage of its features. With the portal (which you can plug into your website) existing patients can view health data & documents as well as schedule appointments. Soon, new patients will be able to fill out intake forms & schedule appointments as well.

In general, if you need to improve performance to get past limitations and related issues in Windows and/or on your network, Client/Server operation may be the answer.

As we gear up for major changes that affect documentation in some states, we have been updating the Encounter with new features. In 2019, you can create & edit your own abbreviations, start new Encounters as you simultaneously work in other parts of ECLIPSE, create macros of any size & add check box lists to your custom grids. Since late 2018, we've also been working on major changes for upcoming NY State Workers Compensation submission.

Every week, we're improving training materials. Your **Help** menu is the gateway to this information, from interactive CMS-1500 forms to various documents, videos & webinars. You can also see what's been added to ECLIPSE since your last update.

Thinking about new CMS programs like MIPS? If so, you'll need the newest versions of ECLIPSE to produce reports. And you'll need ECLIPSE to interact with CMS approved registries to earn more incentives.
