New Full Body Encounter Templates

Carisk Clearinghouse for NY Workers Comp

We have automated claims transfer to Carisk — which includes *automatic upload of your clinical documentation* with each claim. Carisk is an approved submission partner for the NY Workers' Compensation Board. *Any other clearinghouse you might consider is likely sending your NY WC claims through Carisk*.

Soon, NY WC electronic submission of claims & documentation will no longer be optional. You can reach Carisk to begin the setup process via email (sally.balioni@cariskpartners.com) or phone (973-795-1641, select option 2).

United Healthcare (UHC) GP Therapy Modifiers

United Healthcare is once again updating the Procedure to Modifier Policy for claims with dates of service on or after April 1, 2020. Physical therapy (**GP**) modifiers will be required on "Always Therapy" codes to align with the Centers for Medicare & Medicaid Services (CMS). The CMS requires an "Always Therapy" code for certain services regardless of who performs them. Originally (July 2019), this change was aimed at their community based plans only.
